

ST PETERS HEROES MEMORIAL WW2 PLAQUE GRANT APPLICATION.

The Association was recently advised that the application for a grant to fund an additional bronze plaque to commemorate the local service personnel who died in the Second World War has been successful.

The Grant of \$8265 also includes the costs to extend the lighting to illuminate the rear face with the new plaque.

MARDEN & ROYSTON PARK TRAFFIC MANAGEMENT PLAN

In 2021, the Council initiated a project to improve traffic management in Marden and Royston Park. After consulting residents and road users in 2022, and evaluating various street redesign options, the Council is now advancing Stage 1 works.

While this area is not directly in SPRA's main area of interest, it will influence traffic in the Avenues, College Park & Hackney.

DUNSTAN ADVENTURE PLAYGROUND.

It was my pleasure to attend the official re-opening of the Dunstan Adventure Playground on Saturday, 3 February 2024.

The NPSP Council ran a wonderful event with the highlights being the free gelati on what was a very warm day! It was also fabulous to have elected members of the NPSP Council, plus State and Federal representatives, including our premier, Peter Malinauskas, attend and support the event.

The playground re-development is a huge success with new equipment, leisure facilities and beautiful landscaping. Community spaces like the Dunstan Adventure Playground provide places for people to meet, spend time together and get some exercise in the fresh air. After the lack of community connection caused by the COVID-19 pandemic, community spaces promoting wellbeing and connection are more important than ever, and residents of the NPSP Council are privileged to be able to enjoy such a wonderful playground. I encourage all residents to head to the playground to enjoy what it has to offer.

FORMER TRANSPORT SA CARPARK

The State Planning Commission is canvassing options on where land could be provided to accommodate an estimated 300,000 new dwellings in Greater Adelaide over the next 30 years.

Land to be investigated for possible infill development includes the former Transport SA carpark off Holton Court, St Peters. The triangular vacant site is surrounded by the River Torrens on two sides and the O-Bahn on the other. The area is rich in urban wildlife including frequent sightings of koalas and birds.

SPRA is concerned that a large high-rise infill apartment complex on this sensitive riverine site has the potential to add a great deal of pollution to the river and to destroy the amenity of the local environment and its wildlife. We also understand that the former Transport SA carpark is built on fill, due to the history of sand and gravel mining along the River Torrens, followed by use as a rubbish dump.

The recommendation of SPRA is that this land should be added to the Linear Park. This is also the preferred option of the NPSP Council.

PROPOSED 40km/h SPEED LIMIT IN RESIDENTIAL STREETS OF MARDEN, ROYSTON PARK, JOSLIN, ST PETERS, COLLEGE PARK AND HACKNEY.

In August the residents in the area bounded by Lower Portrush Road, Payneham Road, North Terrace, Hackney Road and the River Torrens were consulted regarding Council's proposed introduction of a 40km/h speed limit on the local streets. Stephen Terrace is not included as this road is not controlled by Council.

The results of the consultation were considered by Council Members at the meeting on Monday 4th December, and it was unanimously resolved that the 40km/h speed limit should be implemented. It is planned that the introduction of the new limits will be in late 2024 or early 2025.

STOLEN WATERBIRD SCULPTURE LINDE RESERVE

Late last year SPRA wrote to Council expressing concern at the theft of the Waterbird artworks from Linde Reserve, Stepney

Follow up correspondence to Council earlier this year, indicated that SPRA would like to see the insurance money used for a replacement sculpture that recognises the importance of the artwork as part of the history and cultural heritage interpretation of Linde Reserve. SPRA went on to say that we would like to liaise with Council staff with respect to any replacement being contemplated, as the officers may not know of the history or background to the original project in 2010, and how the works were commissioned and why.

SPRA believes this knowledge is important in guiding the process, as Linde Reserve is an important and unique community space which celebrates both its Kaurna and 19th century German settlement history.
